Notice of Declaration of Candidacy

The Board of Directors in a special called meeting, referenced to the COVID-19 pandemic's adverse impact on our Convention's attendance, voted to recommend that all elections scheduled for the 2021 Convention be postponed until our 2022 Convention. Said recommendation must be approved in the first session of the parent body on July 21, 2021. Should the recommendation prevail and be approved all elections will be held in the 2022 Annual Session of the National Primitive Baptist Convention, USA, Inc.

Anyone who wishes to declare their intent to run for any office should follow the following procedure: Each prospective candidate must personally submit their written letter of intent to General Secretary, Elder Benji McMiller, on or before June 29, 2021. Written letters can be sent via email to: thevoice812@aol.com. You should receive a confirmation of receipt of your letter. Questions can be directed to Elder Benji McMiller at 704-561-1038.

The first list of candidates will be published on July 5, 2021, of all prospective candidates who have met the above deadline. As is always the case in our elections, nominations can also be made from the floor on Wednesday during the 1st Parent Body meeting.

All declared candidates will be considered for the next election.
